

## Frequently Asked Questions for IRES 2021



### ***What is IRES?***

The IRES is the International Renewable Energy Storage conference that has successfully been organized by the European Association for Renewable Energy EUROSOLAR since 2006. The conference has emerged as the central platform for sharing knowledge and exchanging ideas on storage technologies - a key issue of future energy supply. The event is an international gathering of all relevant stakeholders: international scientists and researchers, leaders from the energy storage industries, renewable and conventional energy businesses, grid operators and utilities, from the hybrid and electric vehicle sector, the building trades, science, associations, politics and the financial industry.

### ***When will the next IRES take place?***

EUROSOLAR holds its 15th International Renewable Energy Storage Conference (IRES 2021) on March 16-18, 2021.

### ***Where will the next IRES take place?***

The 15th International Renewable Energy Storage Conference (IRES 2021) will take place online as a global web summit on March 16-18, 2021. This allows scientists all over the world to participate.

### ***What is the conference language?***

The conference will be held in English. If the presentations are assigned to the *third strand*, they will alternatively be held in German.

### ***I am having an oral/poster presentation at IRES2021, do I have to pay a registration fee?***

Yes, all presenters at the IRES conference have to pay a nominal fee. This fee includes the entrance to the whole conference and exhibition and allows the presenters to take part in the networking events. ### ***How much is an IRES ticket? Is it possible to attend only the IRES-sessions?***

Also, it is not possible to only attend IRES-Sessions. For an optimized visit and better networking of the participants, the organizers offer one conference ticket for the full event (ESE + IRES). The Early Bird Price is 180 EUR (incl. VAT).

### ***I am having an oral/poster presentation at IRES2021 and want to submit a final paper. How does this work?***

Full papers may (but do not have to) be submitted by presenting authors at the submission tool ConfTool.pro/ires2021 or via Email to [ires@eurosolar.de](mailto:ires@eurosolar.de) until 10th April 2021. The review process starts from 15th April 2021 onwards. Please make sure to submit your full paper until then. Further information will be send to the authors via email.

### ***Do I need a template for my full paper?***

Yes, you need a template. If you want to submit a full paper for publication (Deadline 10th April), please format your paper in IEEE format. It can be found here (A4)
